**LETTER NO. 2 OF 2020 TO THE CHRISTIAN CARE MEMBER CHURCHES.**

Calvary greetings.

This letter serves as a gentle reminder on the forthcoming Regional/National Annual General Meetings (AGMs). Your denomination is cordially invited to attend the AGMs that are scheduled to take place in the country on various dates as scheduled below. Christian Care would like your church's participation in the organisation's activities at all levels. Remember that the churches own Christian Care and the organisation is incapacitated without the full support of the churches. This communication is coming in as a reminder to the issues already highlighted in the previous communication dated 7<sup>th</sup> January 2020.

**1. Membership Subscriptions**

The organisation would like to thank all member churches that are currently up to date with their subscriptions. At the same time, we humbly appeal to all those in arrears to pay up to enable the organisation to function adequately. The mode of payment for the subscriptions which were sent through the statements and invoices are in RTGS dollar and not in USD. Item 5.3.1 in the Christian Care Constitution states that, *"In voting for any motion, only fully paid up members in good standing order shall be eligible..."*. As such, we would like all member churches to actively participate in making crucial decisions aimed at taking the organisation to greater humanitarian heights. Churches can engage Christian Care and make a payment plan to clear outstanding subscription arrears.

The year 2020 is going to be an elective one. Elections are going to be held at both Regional and National levels to choose new office bearers. Some of the current board members at both levels shall be retained whilst new ones can also be voted into office. Let your church be part of this important process under the Christian Care calendar.



You are being reminded to kindly send us the names of two councillors chosen by your church to constitute the Christian Care National Council. The same concept will apply at the respective Regional levels where each church will be required to submit two councillors who will sit in the Regional Council. It is from the selected councillors that the National/Regional Executive Committees will be selected on the day of the AGM. The positions that constitute the National/Regional Executive Committees are as follows: Chairperson; Vice Chairperson; Secretary; Treasurer; Programmes and Advocacy Chairperson; Human Resources Chairperson; Audit Chairperson; Health and Wellness (HIV/AIDS) Chairperson and Youth Chairperson. Member churches are encouraged to second qualified and experienced persons (in line with the positions given above) into the National / Regional Councils. Thus churches should submit the CVs of the seconded councillors. Critical information which include the Name; Sex; Age; Denomination; Email, business/home Address; Phone Number; and Educational/Professional Qualifications should be included in the CVs.
